SUPPLEMENTARY REGULATIONS

1. TITLE AND NATURE OF THE EVENT

The Event is entitled the 2019 Hedweld Group of Companies Milbrodale Mtn Classic (herein after called the Event), being **Round 3 of New South Wales Off Road Championship** and **Round 1 NSW Off Road Enduro Series, Round 2 of East Coast Tri-Challenge Series.**

The Event will be conducted at the Milbrodale Mtn Race Track, Welshs Rd Milbrodale, 26 Kilometres south of Singleton on the Putty Road on 19th/20th/21st July 2019

This Event is a Long Course Off Road Event run over a variety of surfaces and is designed to test Driver's skill and preparation during daylight hours.

The Event's prologue is approximately 11kms in length and the full distance of the Event is approximately 250kms, comprising of Race 1 Approx. 66ks (6 Laps), Race 2 Approx. 44ks (4laps), Race 3 Approx.22km (4 Laps) Race 4 (6 Laps) Approx.120ks. Format may change due to drought conditions.

2. AUTHORITY AND PERMIT

The Event will be held under the FIA International Sporting Code of the FIA including Appendices and the National Competition Rules of CAMS NCR 56, the Off Road Standing Regulations for Long Course events, the NSW Off Road Championship Sporting Regulations, these Supplementary Regulations and any Further Regulations which may be issued. Where these Regulations differ from the Standing Regulations, these Regulations will take precedence. Any final instructions that may be issued will have the same force as these Regulations subject to NCR's 69 & 89. This Event will be conducted under and in accordance with CAMS OH&S, CAMS Safety 1st and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au.

7. ENTRY DETAILS; NO LATE ENTRIES; Passes will be posted out or Left at the Main Gate if requested. IF YOU HAVE NO Competitor or PIT PASS YOU WILL BE REQUIRED TO PAY AT THE GATE; NO REFUNDS IF THIS OCCURS. Only those persons whose names are on the Entry Form as Pit Crew will be given Pit Access.

Entries are limited to 80 and acceptance will be determined, in order of receipt. All entries must be made via the CAMS On -Line Entry and accompanied by the requisite Entry Fee.

All entered competitors, and pit crew must sign the relevant disclaimers by replying to the email sent to from the electronic entry. If the event is oversubscribed a reserve list will be created and if a Competitor withdraws PRIORITY will then be given to Registered NSW Championship Competitor to replace the withdrawn Competitor.

Entries open on the publication of these Regs and close at midnight 12th July 2019.

The entry fee for the Hedweld Group of Companies MMC will be \$330 (Please nominate if you wish to receive one competitor camping pass).

If the Transponder is NOT RETURNED, A CHARGE of \$600.00 WILL APPLY. ALL TRANSPONDERS ARE TO BE HANDED BACK WHEN PICKING UP YOUR LOG BOOK.

Each Competitor will be allocated four (4) passes (if 4 Competitors all will receive competitor passes, if 3 competitors you will receive 3 competitor passes & 1 Pit pass.

- - two seat vehicle – two (2) Competitor Passes and two (2) Pit Passes, or
- - single seat vehicle - one (1) Competitor Pass and three (3) Pit Passes

Additional Navigators may compete, providing they are properly nominated on the Entry Form, have signed the Disclaimer and the additional Navigator's fee is paid.

Additional Navigators Passes will be available at **\$15.00 each**

Additional Pit Crew Passes will be available at **\$15.00 each. Pit Crew MUST be listed on the Entry Form.**

Persons turning up on the weekend seeking Pit Passes MUST have prior permission from the Entrant/Competitor.

The Organisers reserve the right to refuse any entry in accordance with NCR 83.

8. PASSES (WRIST BANDS): Please ensure your Crew have their passes before arriving at the Event, or know that their passes will be left at the GATE; otherwise they will have to pay at the gate and no refund will be given.

All Competitors & Pit Crew MUST bring Passes to Event Headquarters; these passes will be replaced by an arm band which must be worn at all times. These passes will permit access to the Pit Area whilst racing is in progress.

9 ELIGIBILITY

9.1 Crew Eligibility

- 9.1.1 Points will only be awarded once per vehicle entered, (to the nominated number 1 driver) but there may be more than one driver.
- 9.1.2 Unauthorised person/s in a race vehicle is prohibited.
- 9.1.3 Crew changes will be permitted, but only with persons already entered in the Event. Secretary's/Clerk of Course's permission is required, and all paperwork must be addressed before entering vehicle.
- 9.1.4 All crew shall wear apparel that complies with Schedule D of the current CAMS Manual of Motor Sport.

9.2 Minimum Age

Minimum Age to be in Pits is 16 as per NSW Department of Sport & Recreation rules. (Navigators under this age may only be in pit area when they are entering/exiting vehicles).

- 8.2.1 Driver and Co-Driver Minimum 16 years of age and Navigator minimum 14 years of age (State)
- 8.2.2 One Crew member must be at least 18 years of age and/or hold a valid civil licence.

9.3 Licence Requirements;

NO, NOS, NOJ, NON, NONJ, COJ, CO, CON, NONSE (Single Event Navigator),

NOSE (Single Event Driver) Must be purchased prior to Event. (When paying entry fee.)

10 DOCUMENTATION

All competitors must bring the following documents to Event Headquarters **on Friday 4.00pm to 8.00pm Saturday from 6.30 am to 7.30 am.**

PRIOR TO ATTENDING DOCUMENTATION PLEASE HAVE YOUR SCRUTINEERING PAPERWORK COMPLETED

Documents to be brought to Documentation are: CAMS Vehicle Log Book, COMPLETED Scrutineering sheet, CAMS Competition Licence, CAMS Competitor Pass Book, Proof of Current CAMS-Affiliated Car Club Membership, Proof of Age for under 18 years, Civil Drivers Licence where required. (Please bring along a Gold Coin for donation to a charity.)

11. VEHICLE ELIGIBILITY

All vehicles described in CAMS Manual under Off Road Standing Regulations, Off Road - General Requirements for Off Road Vehicles, GR1 to G30 and GR31 additional Requirements – Specific Requirements for Off Road Vehicles, SR1 to SR6.13 and Appendix 1 and 2.

Vehicles will be classified as follows:

Pro Buggy	Buggies with engines not exceeding 6000cc for petrol engines or 7200cc for diesel engines
Prolite Buggy	Buggies with engines up to 3500cc, naturally-aspirated
Sportslite	(a) Buggy or Extreme 2WD with production car based engines, with engine capacity for naturally aspirated engines to a maximum of 2500cc or four (4) cylinder forced induction engines to a maximum capacity (swept volume) of 1600cc. (10..) (b) Each forced induction engine must be fitted with an inlet air restrictor with a maximum internal diameter of 32mm, in accordance to Appendix 2: Sportslite Restrictor. All the intake air for the engine must pass through this restrictor.
Super 1650 Buggy	Buggies with engines up to 1650cc
Sportsman Buggy	Buggies with engines not exceeding 1330cc
Performance 2WD	Modified 2WD with engines not exceeding 6000cc for petrol engines or 7200cc for diesel engines
Extreme 2WD	Highly-modified 2WD with engines not exceeding 6000cc for petrol engines or 7200cc for diesel engines
Production 4WD	Production 4WD with engines not exceeding 6000cc for petrol engines or 7200cc for diesel engines
Extreme 4WD	Highly-modified 4WD with engines not exceeding 6000cc for petrol engines or 7200cc for diesel engines
SxS Turbo	Off Road Recreational Vehicles (e.g. Polaris, Can-Am) with a supercharged/turbocharged engine of a capacity greater than 1200cc and not exceeding 2050cc. (6..)
SxS Sport	Off Road Recreational Vehicles (e.g. Polaris, Can-Am, Yamaha) with a naturally aspirated engine of a capacity not exceeding 1200cc. (66..) PLEASE SEE OFF ROAD STANDING REGULATIONS in relation to the fitting of Forced Induction.

Maximum noise emission of 95db (a) at thirty (30) metres will be measured and enforced. Any vehicle that does not and cannot comply may be excluded from The Event. This is the maximum allowed by CAMS, The Promoting Club and Singleton Shire Council. OFF ROAD Standing Regulations SR4.5.

All competition vehicles must start every section of The Event with all panels and /or doors attached, unless they are no longer able to be attached. The Chief Scrutineer will check all claims of damage. Any vehicle that arrives at the start line without all their panels and/or doors attached, that has not already notified officials of damaged panels, will be sent back to attach panels and/or doors, and their time will be taken from their original scheduled starting time.

CAMS National Registered Competition Numbers will be given preference over all other state numbers. Refer to: www.cams.com.au

A small contrasting colour, forward facing racing number, at least 70mm high, must be fitted. This is to assist Marshals during line up.

12. SCRUTINY and TRIENNIAL INSPECTIONS

12.1 Triennial Inspections.

A triennial inspection must have been successfully carried out within the prior three years or you must have a log book that is less than three years old.

12.2 Scrutiny- At Event Friday 5pm -8pm & Saturday 6.45am -7.30am

(Request needed for Saturday morning)

All vehicles must have a current CAMS log book and all safety apparel must be presented at Scrutiny for inspection. **Plus First Aid Kit & Fire extinguishers**

Regional scrutiny will be available from these centres during the week prior to the event. Please contact relevant Scrutineer to advise them of attendance. Scrutineers will only attend if advised that Competitors require Regional Scrutiny.

SCRUTINY MAY ONLY BE CONDUCTED BY THE AUTHORISED SCRUTINEERS AT THESE VENUES OR AT THE EVENT ITSELF. ANY COMPETITOR PRESENTING SCRUTINY FORM NOT SIGNED BY AUTHORISED SCRUTINEER WILL BE REQUIRED TO UNDERGO SCRUTINY AT THE EVENT. Scrutiny at Event (see 12.2)

13. RUNNING DETAILS

13.1 Crew Briefing

Crew Briefings will be held at Event Headquarters **at 8.00 am Saturday 20th July and 7.30 am Sunday 21st July**. It is compulsory for all competing Crew to attend and to have signed on prior to the start of each Briefing.

Cases of non-attendance or late attendance will attract a monetary fine. See 16.6 for Penalty.

13.2 Reconnaissance

- 13.2.1 ONLY Competitor vehicles will be allowed to reconnoitre the course at a **NON – COMPETITIVE SPEED**. Only one vehicle per entry. Drivers speed will be determined by the time taken from transponder timing. 8.45 am (Saturday Morning) Prologue Course.
- 13.2.2 Reconnaissance of the Long course **1 lap of the Long Course (Saturday afternoon – minus a section of medium course due to property owners request)**
- 13.2.3 Any Competitor deemed to be driving in a manner not complying with the instructions may be excluded from the Event.

- 13.2.4 If competitors are in an official event vehicle, all occupants must be wearing a seat belt and if using a competition vehicle all crew members must wear the current approved race attire and be strapped in as if for racing. **ONLY COMPETITORS** are permitted to reconnoitre the course. Pit Crew, family and sponsors are not permitted to reconnoitre the course.
- 13.2.5 Refer to Event Time Schedule for reconnaissance of the prologue and course times.

13.3 Prologue

- 13.3.1 A Prologue to determine the start order for Race 1 will be run over one lap of the Medium course after the completion of reconnaissance. **OLT'S will be conducted at the completion of the Prologue.**
- 13.3.2 Vehicles will be started at 1minute intervals. The prologue order will be SxS Turbo, SxS Sport, Extreme 4WD, Sportsman, Production 4WD, Performance 2WD, Sportslite, Super 1650, Extreme 2WD, Prolite, Pro Buggy.
- 13.3.3 Starting order for Race 1 will be determined by the time lost in the compulsory Prologue.

13.4 Event

The Event will consist of Races over the Medium, Short & Long Course Tracks, the surface of which is gravel, dirt and natural surfaces. (Format may change due to drought)

The Event will be conducted over two days and in 4 Races. **PLEASE NOTE; Time/s & format may change at the Clerk of Course's discretion.**

- Race 1 Saturday – will be 6 laps of the Medium Course (11 ks per lap)
Regrouping for Race 2 will be done on the outright order from Race 1
- Race 2 Sunday Morning – Will be 4 laps of the Medium Course (11ks per lap)
Regrouping for Race 3 will be done on the time taken in Race 2
- Race 3 Sunday – will be 4 laps of the Short Course – (5.3Ks per lap)
Regrouping for Race 4 will be done on the accumulative times of Races 1, 2 & 3.
- Race 4 Sunday- will be 6 laps of the Long Course – (20Ks per Lap)
The total competitive distance will be approximately 250 km.

13.5 Time Allowed

- 13.5.1 Time allowed for the Short Course Race will be 30 minutes from your start time
- 13.5.2 Time allowed for the Medium Course Race will be 50 minutes for 4 laps & 75 minutes for 6 laps.
- 13.5.3 Time allowed for the Long Course Race-. The finish line closes one hour after the first car receives the chequered flag.

13.6 Restarting/Stoppages and Regrouping Vehicles causing heat stoppages will be restarted at the rear of the field. Regrouping will be done

14 TIMING AND START LIGHTS/FLAG

- 14.1 Timing officials will be deemed Judge of Fact of Jump Starts, Short Cutting etc. Recovery will be deemed to be Judge of Fact for Short Cutting, passing under yellow flag. (NCR 205)
- 14.2 Timing begins when the signal to start is given.
- 14.3 Times to one thousandth of a second will be recorded on every lap and lap/s within the-time allowed will be counted.
- 14.4 A Competitor's score shall be the total elapsed time for all heats, passing through all controls.
- 14.5 Competitors will be started with a maximum of 2 cars 20 seconds apart for the Medium & Long Course Races, up to 4 abreast at 30 second intervals for the Short Course Race or at the Clerk of the Course's discretion depending on the final number of entries and track conditions.

15 COMPETITION RULES

- 15.1 A vehicle that arrives to the start after its schedule starting time will be allowed to start at the next safe time or at the discretion of the Clerk of the Course, provided it does not impede the start of any other competitor. The elapsed time begins on the original schedule starting time.
- 15.2 A competitor may return to the pit lane during the race through the NORMAL RETURN TO PIT

point, and if re-joining the race must do so through the Start Line access when the starter permits.

- 15.3 Competition vehicles **that are not road registered**, shall not be driven or flat towed on a Public Road.
- 15.4 You are required to supply your own INCIDENT STATUS (OK/SOS) sign for all races.
- 15.5 **Smoking is not permitted** in the Pits, Paddock or in race vehicles at any time during competition.

15.6 **ALCOHOL, DRUGS AND OTHER PROHIBITED SUBSTANCES;**

Any holder of a CAMS "Competition" or Officials" Licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty (ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS Website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

These Supplementary Regulations serve as the required 24 hour notice to all Competitors, Crew and Officials that testing may occur.

16 PENALTIES

- 16.1 JUMP or FALSE START – One Minute for the Prologue. 3 Minutes for all other Races. All wheels must be stationary once the vehicles are under starters orders. Clerk of Course to determine if Penalty needs to be applied.
- 16.2 DELIBERATE SHORT CUTTING or deviation from the course will be 15 minutes for the first offence; exclusion may apply for a second offence.
- 16.3 DANGEROUS DRIVING (as determined by the Stewards) - Exclusion
- 16.4 DELIBERATE INTERFERENCE with or impeding other Competitors a minimum of Five (5) minutes, at the Stewards discretion.
- 16.5 Unauthorised towing for more than 400m on any lap – up to exclusion
- 16.6 FAILURE TO SIGN ON AND ATTEND THE COMPETITOR BRIEFINGS \$250.00 LATE ATTENDANCE \$100.00
- 16.7 Additional penalties may be given by the Stewards.
- 16.8 Passing under Yellow Flag. Regulation as per Off Road Standing Orders 13.5 (a) and (b) and NCR Appendix H 3.1.2(b) (as determined by the Stewards)

17 PROTEST

Protests may only be made in the appropriate manner as outlined in the CAMS Manual of Motor Sport NCR Part XII. (A Competitor Relations Officer will be available)

Crew are reminded that, in accordance with NCR 181A, there is no right of protest or appeal against the decision of a Judge of Fact.

18 SAFETY

18.1 Safety

All Competitors MUST comply with the current National Competition Rules of CAMS. Refer to www.camscom.au

All Drivers and Navigators must wear helmets and apparel as per the current CAMS Manual, General Requirements for Cars and Drivers, Schedule D Off Road 2.3.

Note all crew must wear a Head and Neck Restraint that complies with FIA 8858-2010 or 8858-2002 tethers must comply with FIA 8858-2010.

SCHEDULE D in plain form is attached last page.

Refuelling and Hot Work Area

- 18.1.1 Refuelling at all times must be in accordance with the conditions as per the refuelling requirements in the current Off Road Standing Regulations.
- 18.1.2 **ALL REFUELLING at the venue MUST BE DONE IN the Refuel area. All persons involved in**

refuelling operations, or within two metres of refuelling or venting points whilst the vehicle is being refuelled, are to wear the correct attire of a minimum attire of at least shoes with non-flammable socks and clothing from waist to neck to ankle, and have the minimum fire extinguisher as set out in the current CAMS Manual. ALL PERSONS MUST BE OUT OF THE VEHICLE Refer to Standing Regulations.

CONTRAVENTION OF THIS RULE WILL LEAD TO IMMEDIATE EXPULSION FROM THE EVENT

- 18.1.3 ALL WELDING, OPEN FLAMES and GRINDING must occur in the HOT WORK AREA (OFF ROAD Standing Regulations)
- 18.1.4 Any competitor who contravenes 18.1.3 will be excluded from the competition and asked to leave the venue.
- 18.1.5 FUEL must comply with Schedule G of the CAMS Manual of Motor Sport.
- 18.1.6 **All Vehicles are required to carry a minimum of 5-watt radio either handheld or fixed at ALL Events.**
- 18.2 Course Markers**
The course is marked as per the Off Road Standing Regulations for Off Road Events.
- 18.3 Judges of Fact**
Control Officials/Recovery, Starter and Timekeepers will be deemed Judges of Fact with regard to whether or not a vehicle follows the prescribed course, relative order, time of arrival, direction of travel, direction of entry into controls, start procedure and jumping the start. Time keepers will be deemed Judges of Fact as to whether a vehicle exceeds speed limit on reconnaissance. Recovery officials, and control officials will be deemed Judges of Fact with regard to track deviation/short cutting.

19 POINTS AND AWARDS

- 19.1 NSW OFF ROAD CHAMPIONSHIP CONDITIONS (Sponsored by Hunter Rivmasta)**
This can be contested by any CAMS National Off Road/Rally/Clubman Licence holder (OFF ROAD Standing Regulation 3.3-iii complying with 3.1) See the NSW ORC Sporting Regulations referring to the conditions required to gain points.
- 19.2 DETERMINATION OF THE WINNER OF THIS NSWORC ROUND**
The Competitor that completes the most distance in the least time (including Penalty time) is the winner.

- 19.4 Milbrodale Mountain Classic AWARDS**
The following trophies will be awarded at the completion of the Event.
Trophies will be awarded to Drivers and Navigators 1st, 2nd and 3rd in each class plus
- Outright winner (Bob Stansfield Award)
 - Fastest Prologue Driver in each Class
 - Best Presented Car
 - Man of the Mtn (fastest single lap of Driver who finishes the entire laps in the long course.)
 - Nigel Beeston Trophy (HVORRA Member)
 - Best Female performance (Driver & Navigator) overall.

20 PIT AREA

Refer to Current CAMS Manual and Current Off Road Standing Regulations.

- 20.1 A Pit will be in use for the duration of the Event.
- 20.2 Pit Crew must be wearing the minimum attire as follows - T Shirt, cargo shorts, closed in shoes.
- 20.3 All Pit and Competing Crew must display their armbands on the outside of garments at all times whilst in the Pit Area.
- 20.4 All persons associated with a vehicle in pits must have signed on and be wearing the appropriate wristband to enter the Pits. Other than a competing Crew member, no one under the age of 16 may be in the Pits. Unless Pit Crew name is on the Entry Form there will no pit access for others.
- 20.5 Smoking or the consumption of alcohol is not permitted in the Pit, Refuel or Hot Work Area.

- 20.6 The Pit Lane will be clearly signed and fenced.
- 20.7 Entry in and out of Pit Lane must be via the designated entry and exit point/s.
- 20.8 **The maximum permitted speed is 10km/hour. This includes the Pit entry from the Race Track.**
- 20.9 All competing vehicles must be located in the designated Pit Area during the event and must be serviced from this area ONLY.
- 20.10 During competition, any vehicle which leaves the pits, other than to re-join the event or to go to a designated refuelling area will be deemed to have withdrawn from the event unless permission is sought from the Clerk of the Course.

Breaches of any of these Regulations may be referred to the Stewards by way of a formal charge, which may result in a penalty.

21 GENERAL

- 21.1 Officials will be supplied with an Official Pass that is to be worn on the outer of clothing at all times.
- 21.2 **At the completion of the day's competition** NO vehicles other than officials involved in recovery and final sweep are to be on the course.
- 21.3 **No persons** are allowed on the course without permission of the Clerk of Course
- 21.4 **Vehicle testing;** the Organising Committee will not allow vehicle testing on access roads or in the Spectator area, rural lands or in the Pit Area at any time. This may bring exclusion from the event.
- 21.5 **Medical Facilities** will be provided by Beneficial Safety.
- 21.6 **Recovery Vehicles** shall recover competition vehicles after each competitive race or at the Clerk of Course direction. Any competitor that needs to be towed by another vehicle (other than an Official Vehicle provided by the Organiser) will need permission from the Clerk of Course.
- 21.7 A condition of entry is that the track can be watered at the discretion of the Promoters and no Protest will be accepted on this action, or Timing, Regrouping and Heat Order.
If there is any aspect of this Race Meeting that causes you concern for your personal safety or for that of any member of your crew, whether that concern be with the Race Track, the Venue or for that matter in which the Race Meeting is being conducted you are advised to hand in your transponder, collect your Log Book and withdraw from the Race Meeting
